## Section 2: HAZARDS IDENTIFICATION

## Section 3: COMPOSITION/INFORMATION ON INGREDIENTS

**General information:** Aqueous solution of recombinant human Transcriptional intermediary factor 1 gamma (TIF1 gamma).

**Ingredients:** This product is a mixture of substances.
